

Meeting of the IDF Management Board

The President Leandro Senesi welcomes the members attending the meeting and opens the meeting.

The President points out that the meeting of the Management Board has been convened to form a technical and a judges' committee and because of the poorly organised General Meeting. Then he explains his reasons; mostly that some enquiries and proposals were not appropriate for discussion at the General Meeting, but should be discussed at the Board Meeting.

Aleksandr agrees with Leo's explanation, i.e. that not everything was appropriate for the General Meeting.

Leo says that the General Meeting was poorly organised from the technical perspective and he takes his responsibility for that. However, with regard to the resolutions, they were passed and adopted. Anyway, from now on the tasks will be clearly distributed any everyone will know their duties.

Agata stresses that it is not possible to change everything all of a sudden and to interrupt somebody's work, these changes will take time and stage managers will need some time to get into the swing of things.

Leo stresses that rules need to be followed.

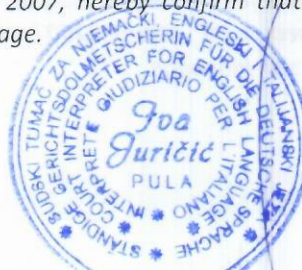
Robert says that these new persons must be trained and start working, there is enough time until the World Championship, some workshops can be organised. We should let them gain experience at national competitions.

Aleksandr stresses that language could be a problem as some of them speak English very poorly or barely speak it.

Leandro points out that the official language is English and that there will be an interpreter for English on each stage, as specified in the contract.

Bartolo says that we have enough stage managers who have passed the exams and training and have gained experience at initial and show competitions, and that he does not want to have them only on paper but also in practice and use them as such. If there are any issues and they need help, it is always possible to help them.

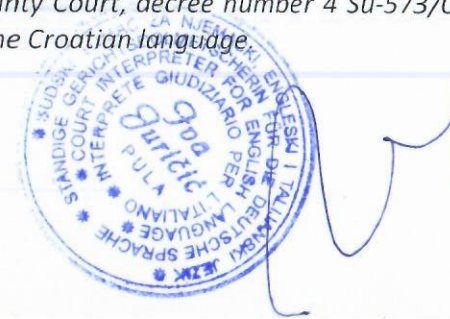
